On the implementation of Regulation (EU) No 1026/2012 in the context of the mackerel dispute

Deadline for replies: 11 February 2013

Background

Regulation (EU) No 1026/2012 (hereinafter the Regulation¹) lays down a framework for the adoption of fishing-related measures with regard to third countries in order to ensure the long-term conservation of fish stocks of common interest to the Union and those countries

This consultation is part of a fact-finding exercise allowing the Commission to assess the situation in the context of the mackerel fishing by Iceland and the Faroe Islands. It is of an exploratory nature and does not prejudge whether the measures envisaged below will or will not be actually implemented as such.

Questionnaire: possible effects of the measures foreseen in Article 4 of the Regulation. For the time being, this consultation refers uniquely to mackerel, but this is without prejudice to including other associated species, for which a separate consultation would eventually be made.

1. **Restriction on importation of mackerel and mackerel products**

<u>Measure 1</u>: Total prohibition or significant restriction on importation from Iceland and the Faroe Islands of mackerel *Scomber scombrus* (fresh, frozen fillets, whole frozen, gutted and headed frozen and elaborated products such as canned, marinated and smoked mackerel where the mackerel content may be easily identified)

Measure 3: Total prohibition, or significant restriction, on the use of Union ports by vessels flying the flag of Iceland or the Faroe Islands that fish mackerel and/or associated species and by vessels transporting mackerel or products of mackerel that have been caught under the control of Iceland or the Faroe Island, except in cases of force majeure. It will be for the Commission to establish regularly the lists of the vessels that fish for mackerel and for member States to check the cargo of vessels intending to call in EU ports in order to determine whether they are transporting concerned mackerel or mackerel products.
