Dear Mr Sverdrup-Jensen,

Thank you for your letter dated 20 June 2025 regarding the NWWAC and PelAC position on the setting of fishing opportunities for sprat in the Chanel and your comments on wider ecosystem considerations regarding forage fish species such as sprat. I am pleased to inform you that the outcome of the EU-UK consultations was aligned with the NWWAC/PelAC position to follow the ICES advice in full.

I note your concerns regarding the uncertainties of the stock structure. You consider that this should be resolved before any progress can be made with a management strategy. I am aware of ongoing scientific work on genetic analysis ⁽¹⁾ as well as progress in developing ecosystem-based management plans for sprat in the Celtic Sea ⁽²⁾. Hopefully, when this work is complete, and incorporated into the ICES process, it will improve the current understanding of the sprat stocks in the Western Waters and will form the basis for a future management strategy.

I would like to once more thank you and the members of the NWWAC and the PelAC for your active involvement and views regarding the consultations. I am looking forward to our continued fruitful cooperation.
